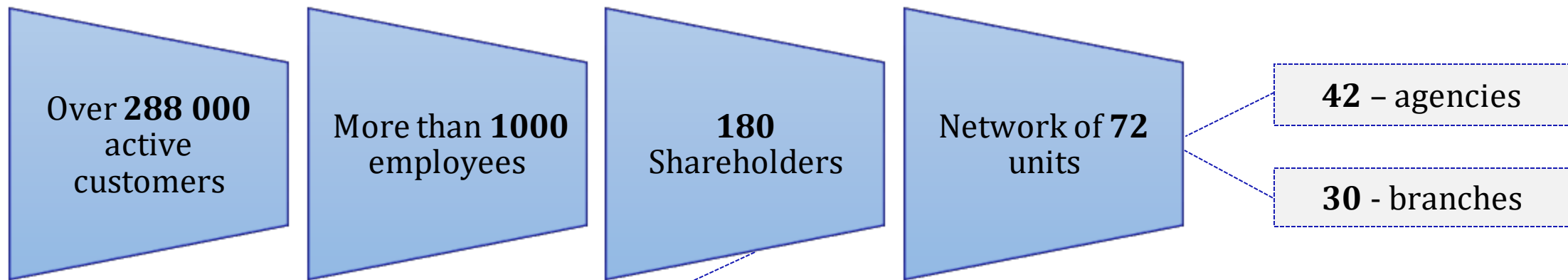

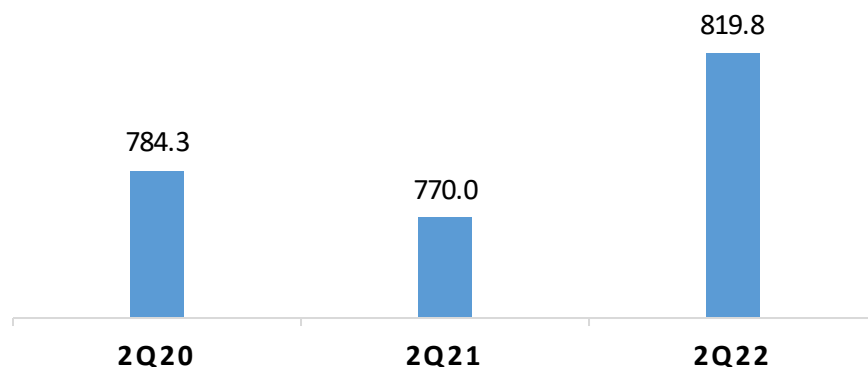

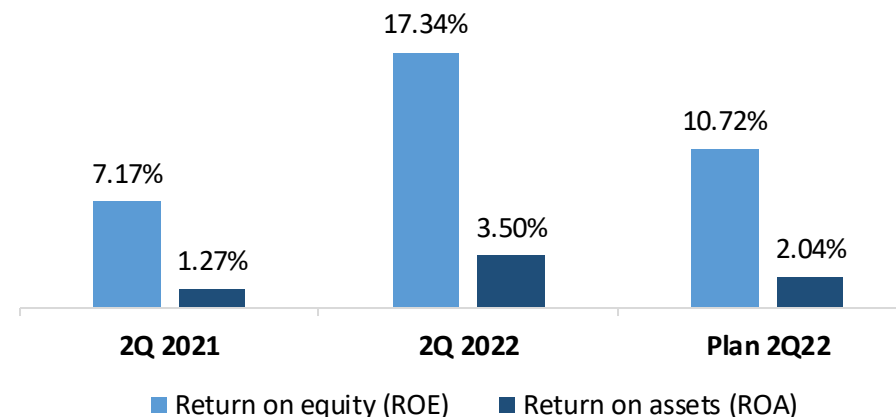

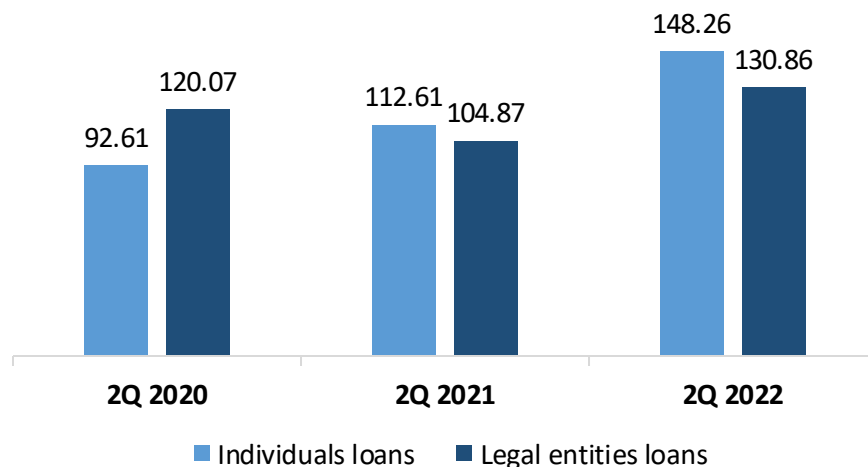
Assets (mln EUR)



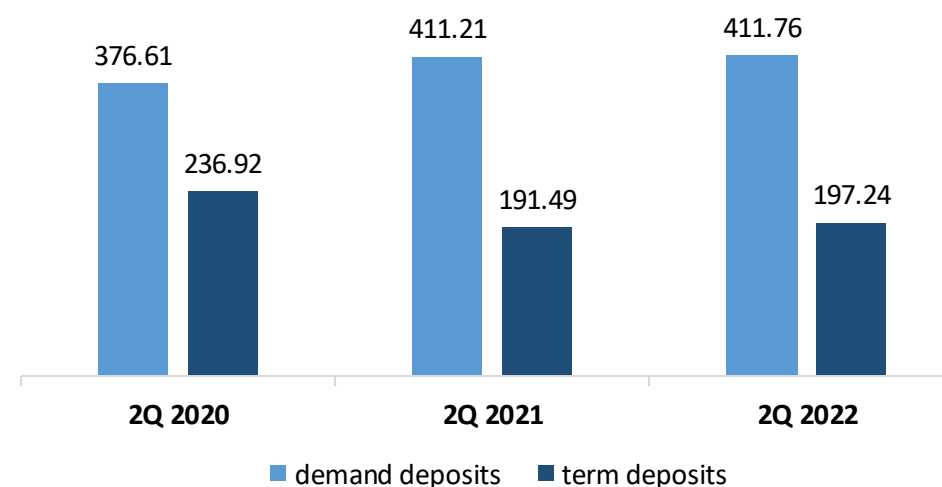
Profitability ratios ROE/ROA



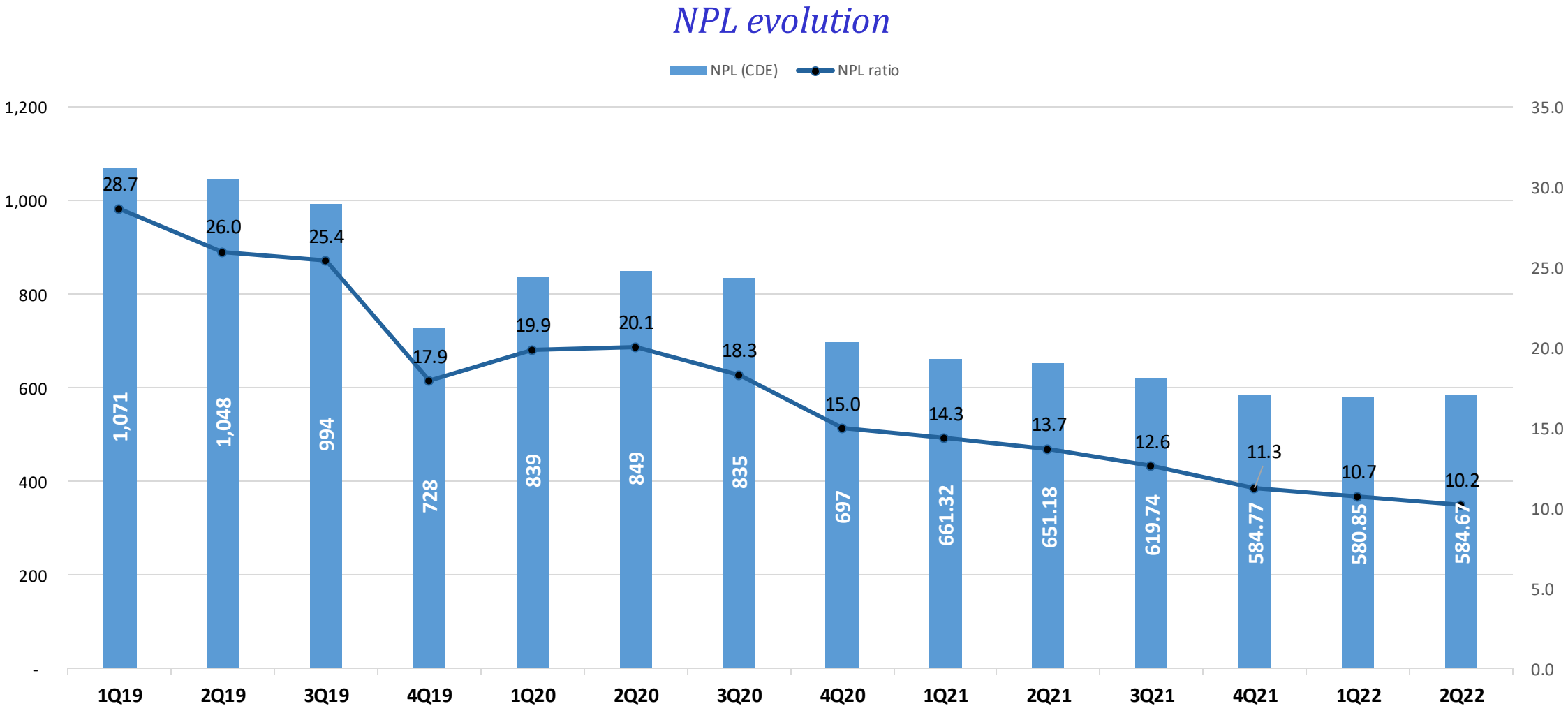
Loans (mln EUR)



Deposits (mln EUR)

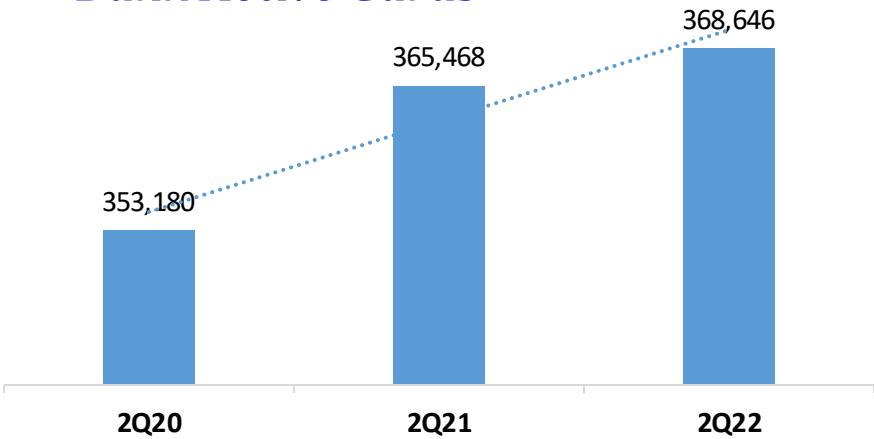

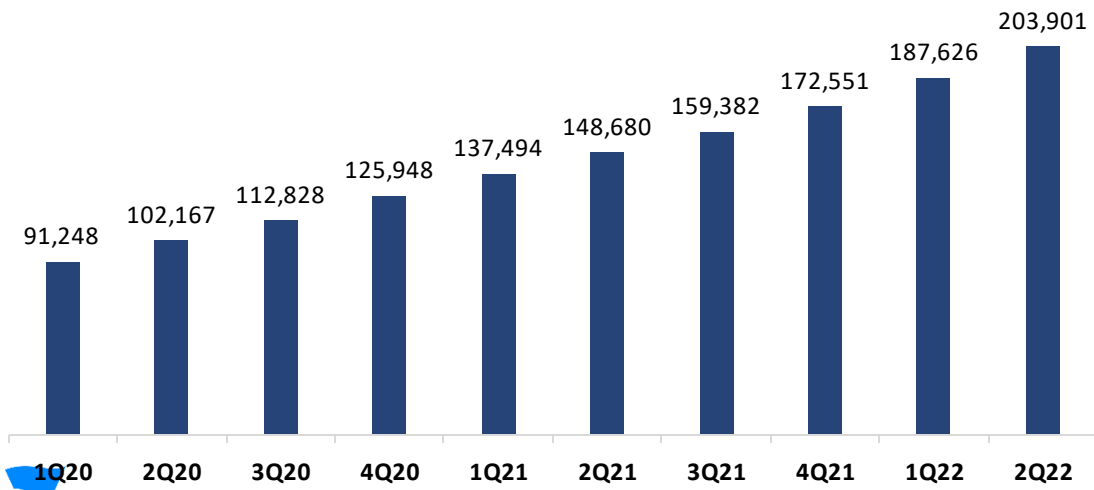

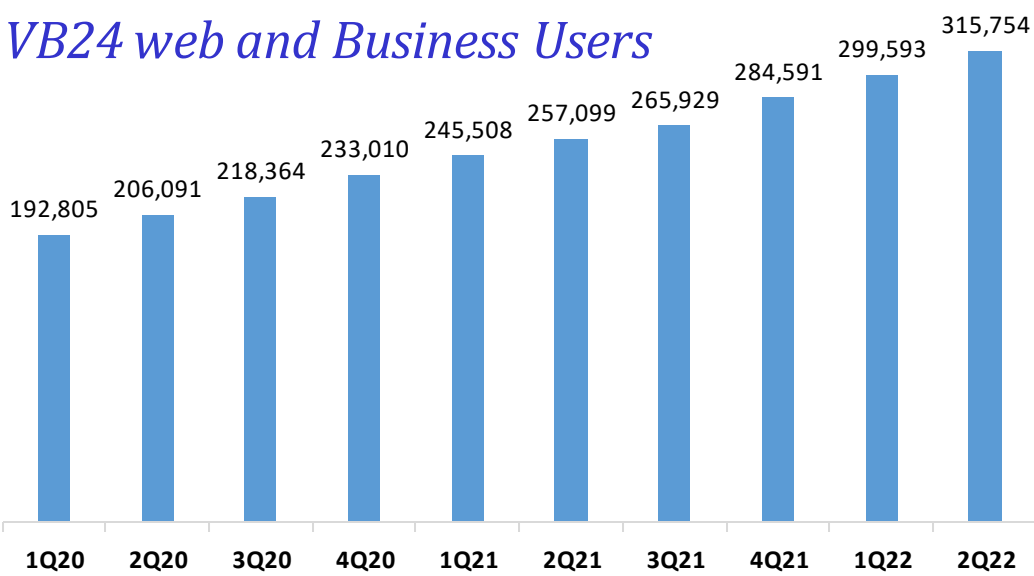
Bank Active Cards



Mobile Banking Users

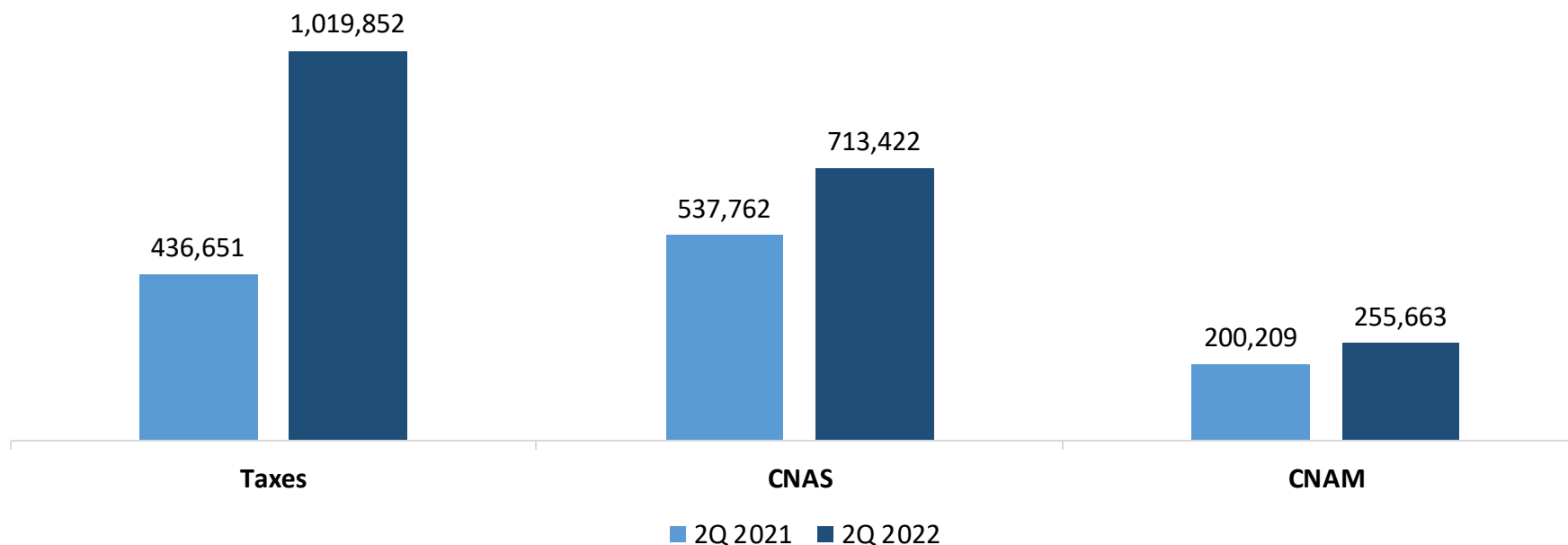

Taxes: income tax withheld from salary, from entrepreneurial activity, withheld at the source of payment, property tax, VAT, landscaping fee, advertising device fee, road use fee, and so on

IV. HIGHLIGHTS: *Key achievements Q2/2022*

Victoriabank - significant **contributor to the state budget:**

- ✓ over **150 million lei** contributions to the state budget in the form of taxes and duties (in Q1 2022 - by 10.5 million lei following the payment of the income tax obtained from the entrepreneurial activity)
- ✓ over **4.7 billion lei** - investments in government securities (as of 31.12.2021, Victoriabank - the largest investor in State Securities (SS) in the RM, holds approximately 24% of the total SS issued by the Ministry of Finance).

In the 3rd edition of financial-banking training program - **Zoom in Banking**, VB organized paid internships for ASEM/USM students/graduates.



10,000 holders of social cards have already benefited from prizes within the national campaign "**Alături de Moldova, alături de fiecare**"

- ✓ approx. 5,000 customers received 10% cashback when paying bills online for communal services;
- ✓ approx. 5,000 other customers received 10% cashback after shopping in pharmacies.

Between March - June, Victoriabank offered over **3 million lei to users of social cards** in the form of cashback and bonuses for issuing cards, in the promotion for social cards, within the above mentioned campaign.


IV. HIGHLIGHTS: *Key achievements Q2/2022*

Under the **#CashLess** motto, Victoriabank recorded: the largest number of digital transactions from all Victoriabank operations; the highest value of **digital transactions**, as well as the highest average monthly transactions with an active card.

VB continues the implementation of the social campaign (budget >10 million lei) which will be implemented until the end of 2022. VB offers maximum convenience and speed in using digital services. Through the new digital service **Cash-Out/In by Code**, VB customers can deposit/withdraw money at the ATM **without using the card**.



The **VB ATM network** has been modernized with **100 state-of-the-art ATMs**, unique on the market in the RM. VB continues the process of improving and developing alternative banking and self-service solutions, investing in innovations and strengthening the status of a **digital bank**. Starting this July, VB will also add the functionality of replenishing the account in the Romanian national currency - **RON**.
